Mr. Harvey,

Thank you for your clarification. I am following the current Policy 6300 as per our last board meeting. In section D – Procedures for Reconsideration of Materials, D–2 does say "complaints should be presented to the Principal of the school where the material is used" I did ask if I could email the Principals and was told yes. I am very appreciative that both Principals I have contacted have been very proactive in removing the books from the shelves. Principal Halvorsen's response was, "The books will be removed indefinitely pending review." Principal Campin's response was, "The books will be pulled from the shelves and be put in our review process." Again, I want to reiterate that I am extremely thankful that both gentlemen have taken quick action and are reviewing the books.

Maybe I should have worded my question differently. D–3 states, "When a formal written complaint is completed and returned to the principal, the principal will discuss the issue and the procedures to be followed in resolving the issues with the person filing the complaint. The principal with whom the complaint was filed shall notify the other school administrators, and also advise those faculty members who may use the instructional material, or the media staff in the case of media material, that a complaint has been filed. The school administrators shall decide whether to appoint a building–level review committee or a district–level committee to study the complaint. The building–level committees shall consist of five or more committee members composed of staff and community patrons. The superintendent of schools or his designee will convene district–level review committees. These district–level committees shall consist of five or more members composed of staff and community patrons."

As the "person filing the complaint" I was asking for clarification on what this review process mentioned by both Principals would be, I failed to word that question correctly. I should have asked whether they plan to do a building-level or district-level committee to do the review. Another question I have, reading the policy again, is the definition of "community patrons".

My desire and intentions are not to make this process difficult or to be perceived as aggressive toward our hard working Principals and staff. My passion comes from both shock at the type of material I have found and my desire to protect our students from material, that by every objective and legal definition, is pornographic. My urgency comes only from wanting to uphold the high standards of our school district and our community. Being new to the Board and these procedures and policies, I am trying to ask important questions so I get a thorough understanding of all of it. As I stated in the previous emails, we in the American Civics Committee are working through the policies, and I think being involved, informed and educating myself in the details of walking through this process would be very helpful to me and other ACC members as we walk through this process.

Thank you all for the spirit of cooperation that has been so evident and encouraging. We are on the same team, and I believe we have the same goals and standards we want to attain to make Plattsmouth Community Schools the absolute best district in the region.
