Incident Information: On Saturday, July 2nd, 2022 at approximately 9:30 AM, I was preparing to leave my home for an appointment. This is when I noticed a blue truck parked in front of my mailbox and blocking access to it. The truck was also blocking a part of our driveway which made it necessary for me to take our other car, as I could not back my vehicle out of the driveway.

I went back inside and called Lisa Pitt's cell phone and left her a voicemail to please move the truck blocking our access. We share a very close front section of the property where my mailbox is located. Lisa Pitts never responded to my voicemail and did not move the truck. Thus, as I was leaving I placed a yellow sticky note on the truck's side window asking to please not park in front of my mailbox.

As I was backed out of my driveway, I noticed that the owner of the truck entered the vehicle as I left the area. I was a bit concerned when I left, but as I turned north on Highway 75, he took the exit south to Highway 75. At this point, I felt the situation was resolved. I now know that he went back and parked his truck in the same place, again blocking my mailbox and part of my driveway.

I returned home about 2:00 PM and noticed that there was a new car parked illegally in front of our mailbox. I went inside my residence and spoke with my wife & my daughter who were inside and visibly upset and shaken. They were upset because of the altercations that they had experienced with Lisa Pitts earlier in the day.

After a while, I was outside in my front yard to get a small metal strip from the back of my truck and I noticed that there was now a different vehicle parked in front of our mailbox again. A

young man walked up and opened the trunk of this vehicle. I said to him, "Sir, would you kindly move your car from in front of my mailbox"? The young man then replied "We are having a party down the there." The young man pointed towards a house three houses down from mine & that is where a very good friend of Lisa Pitts lives. They were basically going between Lisa Pitt's house and to the neighbor's house down the street for a party. The young man replied that they were attending a party at the house of Lisa Pitt's friend and there is nowhere to park. I responded, "Well this is really not a parking area, especially in front of my mailbox." There was room in the driveway of Lisa Pitt's house to park and I suggested to park it there since they are all together at this party. The young man replied, "Ok, but let me take this bag of stuff down to where we are having the party." I said that was fine.

Approximately 10-15 minutes later I went back outside to my truck and my wife walked out with me. As we were in the driveway, we started hearing voices shouting at us in a very abusive manner. It was coming from Lisa Pitts and a friend of hers. Specifically, Lisa Pitts said to us, "What the f*** are you talking about me now?" I looked down the street and saw that Lisa Pitts was standing on a trailer bed yelling profanities at my wife and me and continually flipping us off. Lisa Pitts specifically said to us, "Why don't you quit bothering us and go inside your house and die, you old f***ers." I looked down the street where all of this was coming from and again Lisa Pitts said, "I wish you all would die. We need young people on this street, and not you old ass*****. Go inside and die!" Then a friend of Lisa Pitts from the party, Cassie Plessel, stormed across 2 of our neighbor's yards and came up to our property line, all the while being egged on by Lisa Pitts. She continued to rant at us for several minutes and we felt threatened by Lisa Pitts and Cassie Plessel. Cassie Plessel was clearly doing this because Lisa Pitts was angry with our family.

As such, my wife and I moved back into our garage as it was so offensive to be out front. My wife and I felt very concerned about Lisa Pitt's behavior and her role in getting Cassie Plessel to confront us in such a harassing way. As we entered the garage, there came another burst of obscenities coming from Lisa Pitts and she continued flipping us off. Again, Lisa Pitts kept saying "F*** you, we have more of these for you (referencing her and Cassie Plessel giving us the finger), how many do you want?" It was absolutely verbal abuse and we were not engaging with them any longer.

My wife and I got back inside the house and after discussing the situation with my wife and daughter; I decided to call the Sheriff's Office to make a record of what had occurred that afternoon. I asked that the Sheriff please not come out here because I was afraid it would cause further escalation in the behavior of Lisa Pitts.

Lisa Pitts has demonstrated very disrespectful, abusive, and harassing behavior to me and my family. Due to the above interactions with Lisa Pitts, along with past harassing behaviors from her, I do not feel comfortable going outside of my home.

I fear that Lisa Pitts behavior may continue to escalate towards my family and as such, I am requesting a protective order to be filed against Lisa Pitts of 2708 Fountain Circle.
